(i) Stephen Louis Rhodes is a beneficiary of 5,838,384 ordinary shares of the Listed Issuer held in trust by the Meitav Dash Trust Ltd.; and

(ii) Stephen Louis Rhodes has 45% shareholding interest in T.D.L International Directions Ltd. ("TDL") (formerly known as Trendlines International Ltd.).

TDL holds approximately 99.8% of the shareholding interest in Trendlines Venture Management Ltd., which is the general partner of Trendlines Venture Partners L.P., which, in turn, is the general partner of TIF, a fully-invested venture fund that held 9,411,768 Ordinary Shares of the Listed Issuer ("TIF Shares") prior to the Distribution.

In this context, Stephen Louis Rhodes is indirectly interested in the TIF Shares because Stephen Louis Rhodes is a director and shareholder of Trendlines Venture Management Ltd., (which, as noted above, is the general partner of Trendlines Venture Partners L.P., which, in turn, is the general partner of TIF), and Trendlines Venture Partners L.P. (as the general partner of TIF) has the exclusive right and power to manage the business and affairs of TIF, which includes the authority to dispose of, or to exercise control over the disposal of, the TIF Shares.
