**(1) CESSATION OF CHIEF FINANCIAL OFFICER (“CFO”) AND APPOINTMENT OF INTERIM CFO**

The Board of Directors (the “**Board**”) of The Trendlines Group Ltd. (the “**Company**”) wishes to announce that Ms Gabriela (Gabi) Heller had tendered her resignation and will cease to serve in the position of CFO effective 30 June 2018 to pursue other business interests and career opportunities. Ms Gabriela (Gabi) Heller will stay in the Company until 10 October 2018 to facilitate the smooth handing over of the position and ensure an orderly transition.

The responsibilities of Ms Gabriela (Gabi) Heller as CFO will be assumed by Mr Haim Brosh, the current Financial Controller of the Company, who has been with the Company for the past 4 years. Following the aforementioned cessation, Ms Gwendolin Lee Soo Fern shall continue to act as the sole Secretary of the Company.
