**Clarification Announcement on Irrevocable Instructions for
Purchase of the Company's Shares by the Chairmen**

The board of directors (the "**Board**") of The Trendlines Group Ltd. (the "**Company**") refers to the Company's announcement dated 31 August 2016 (ref: SG160831OTHROK6W) regarding the irrevocable instructions for the purchase of the Company's shares by the Chairmen ("**Earlier Announcement**").

The Company had in the Earlier Announcement informed shareholders, amongst other things, that the purchase of the Company's shares shall take place on 21st day of each month, with the first purchase of the Company's shares commencing on 21 November 2016.

The Company wishes to clarify that the twelve irrevocable instructions to purchase the Company's shares should be on the **5th day** (or the next Singapore and Israel business day if the 5th day falls on a non-business day in either countries) of each month instead of the 21st day. As such, the first purchase of the Company's shares shall take place on **5 December 2016**, with eleven subsequent monthly instructions executable once per month thereafter for eleven months, making a total of twelve purchases.
