(f)	Validity period of the Options	:	10 years from date of grant
(g)	Exercise period	:	The vested Options are exercisable only after 12 months from date of the grant. One third (1/3) of the Options will vest and become exercisable after 12 months from the date of grant and the rest of the Options will vest and become exercisable in monthly installments over a period of 24 months thereafter
