Chief Financial Officer and Joint Company Secretary,  
Effective June 30, 2018**

**Misgav, Israel – 12 June 2018** -- The Trendlines Group Ltd. (the “Company” or “Trendlines”) today announced that Ms Gabriela (**Gabi**) Heller, Chief Financial Officer (“CFO”) and Joint Company Secretary, is leaving the Company in the coming months to pursue other interests. The Company expects to announce a successor in the next few weeks and has appointed Mr. Haim Brosh, the current Financial Controller of the Company, as Interim CFO for the time being. Ms. Heller will step down from her current positions effective June 30, 2018, and will remain at Trendlines until October 10, 2018, to facilitate the smooth handing over of the position and ensure an orderly transition.

Ms. Heller has served Trendlines as CFO since 2010, playing an instrumental role in the continuing growth of the Company, in the Company's public listing in Singapore in 2015, and in solidifying its financial strength and global operations.

Steve Rhodes, Chairman and CEO, stated, "Gabi has been a valued member of our management team for eight years, contributing greatly to the success of our business. On behalf of myself, the Board, and the Company, I would like to thank her for her work in our behalf. She has helped strengthen virtually every aspect of our operations, our procedures, and our financial reporting."

Gabi Heller commented, "After eight years at Trendlines, including making the transition from a private company to a publicly listed company, and with the Company in a strong financial position, I believe it is the right time for me to enter the next chapter of my career." She continued, "I'm proud to have been part of Trendlines' achievements during the past eight years. I leave the Company both financially and operationally strong at an extremely exciting time in its development. I enjoyed my time with the Company and feel privileged to have been part of the Trendlines family. I would like to thank my team for their outstanding support and look forward to seeing Trendlines continue to grow and deliver value to its shareholders."

In accepting Ms. Heller's resignation, the Company's Board of Directors named Mr. Haim Brosh as Interim CFO while the process of naming a permanent replacement for Ms. Heller moves forward. Mr. Brosh is a Certified Public Accountant in Israel and has acted as the Company's Financial Controller since 2014.
