**Irrevocable Instructions for Purchase of the Company's Shares by the Chairmen**

The board of directors (the "**Board**") of The Trendlines Group Ltd. (the "**Company**" or "**Trendlines**") wishes to announce that the Company's Chairmen, David Todd Dollinger and Stephen Louis Rhodes (collectively, the "**Chairmen**"), have each advised the Company that they have delivered irrevocable instructions to their respective banks to purchase shares in the Company on the open market, according to the terms described below (the "**Share Purchase**").

Each of the Chairmen has given his bank twelve irrevocable instructions to purchase NIS (New Israel Shekel) 3,000 worth of Company's shares on the 21<sup>st</sup> day (or the next Singapore and Israel business day if the 21<sup>st</sup> day falls on a non-business day in either countries) of each month, irrespective of the price per share on the date of the purchase. The first purchase of the Company's shares shall take place on 21 November 2016, with eleven subsequent monthly instructions executable once per month thereafter for eleven months, making a total of twelve purchases. As of 30 August 2016, NIS 1.00 = S\$ 0.36, and NIS 3,000 was approximately S\$1,080.

**Interest of Directors and Substantial Shareholders**

Save for the Chairmen, none of Trendlines' Directors, substantial shareholders and/or any of their respective associates has any interest, direct or indirect, in the Share Purchase.

Upon the execution of each Share Purchase, the Chairmen shall notify Trendlines to make the necessary disclosure on the change in the Chairmen's shareholding interests as required under the Securities and Futures Act (Chapter 289) of Singapore.
