**RESPONSE TO SGX-ST'S QUERY REGARDING TRADING ACTIVITY**

The Board of Directors (the "**Board**") of The Trendlines Group Ltd. (the "**Company**") refers to the query raised by the Singapore Exchange Securities Trading Limited ("**SGX-ST**") on 30 October 2017 in relation to the unusual volume movements in the Company's shares ("**SGX Query**") and wishes to provide the Company's response to the SGX Query as follows:

- 1. Are you (the issuer) aware of any information not previously announced concerning you, your subsidiaries or associated companies which, if known, might explain the trading? Such information may include events that are potentially material and price-sensitive, such as discussions and negotiations that may lead to joint ventures, mergers, acquisitions or purchase or sale of a significant asset. You may refer to paragraph 9 in Appendix 7A of the Catalist Rules for further examples. – If yes, the information shall be announced immediately.**

The Company's announcement dated 10 October 2017 (Section 3), included reference to a strategic review in respect of the Company's operations within a reasonable period of time as well as a possible implementation of a dividend policy.

The Board had today discussed and finalised a dividend policy and strategic review plan. Details of the aforementioned will be contained in separate announcements to be released by the Company today.

Further, the Company is continuously exploring potential exits of some of its portfolio companies. Further announcements will be made by the Company via SGXNET as and when there are any material developments in relation thereto, in compliance with the SGX-ST Listing Manual Section B: Rules of Catalist ("**Catalist Rules**").

The Company is unable to conclusively attribute the information disclosed above to the trading activity.

Save for the foregoing, neither the Company nor its Directors are aware of any other information which has not been previously announced regarding the Company, its subsidiaries or portfolio companies that might explain today's trading activity.

- 2. Are you aware of any other possible explanation for the trading? Such information may include public circulation of information by rumours or reports.**

The Company is not aware of any other possible explanation for the trading, apart from the information disclosed above and the Company's previously announced information.

- 3. Can you confirm your compliance with the listing rules and, in particular, Catalist Rule 703?**

The Company confirms its compliance with the listing rules of the SGX-ST, in particular, Catalist Rule 703.

The Company has obtained the Board's approval on the aforesaid replies to the queries raised by the SGX-ST. In addition, the Board collectively and individually takes responsibility for the accuracy of the aforesaid replies to the queries raised by SGX-ST.
