



Trendlines Medical Singapore and A*cceleerate establish partnership to jointly develop and commercialise medical technologies

Misgav, Israel and Singapore, 11 November 2018 – The Trendlines Group Ltd. (the “**Company**” and together with its subsidiaries, “**Trendlines**” or the “**Group**”), a leading Israeli-based investment and innovation commercialisation company focused on early-stage, high growth medical and agricultural technologies, announced today that its wholly owned subsidiary, Trendlines Medical Singapore Pte. Ltd. (“**Trendlines Medical Singapore**”) has entered into a Memorandum of Understanding (“**MOU**”) with Accelerate Technologies Pte Ltd (**A*cceleerate**) for both parties (“**the Parties**”) to collaborate and explore potential joint research and development initiatives in several medical technology areas.

Under the MOU, Trendlines Medical Singapore and A*cceleerate will work together to identify technology from A*STAR with the intention of spinning-off up to five start-up companies that will benefit from Trendlines Medical Singapore’s expertise in medical device incubation and A*cceleerate’s technology development capability. A*cceleerate will contribute to the technology and product development for each start-up company, and Trendlines Medical Singapore will invest and incubate these start-up companies in the same way as our current and other companies. There will be no additional costs to Trendlines Medical Singapore as a result of this partnership. For the initial activity, the Parties have identified projects in the field of ultrasound guided therapies, neurorehabilitation, radiology, ophthalmology, urology, and gastroenterology to commence this partnership.

A*cceleerate is the rebranded entity of what was formerly known as ETPL, the commercialisation arm of the Agency for Science, Technology and Research (“**A*STAR**”). It supports A*STAR in transforming the economy by driving innovation and commercialising its research outcomes. A*STAR is Singapore’s lead public sector agency that spearheads economic oriented research to advance scientific discovery and develop innovative technology.

Chairman of Trendlines Medical Singapore Todd Dollinger commented, “The partnership with A*STAR and A*cceleerate deepens our resolve to strengthen our partnership with

hospitals and research institutes to boost the medical device start-up eco-system in Singapore. It's the shared mission of A*STAR and Trendlines to advance science and develop innovative technology to improve lives, and we are pleased that Trendlines will play a meaningful role in the incubation and commercialisation of medical technologies in the process for Singapore to achieve this mission."

According to Philip Lim, Chief Executive of A*ccelerate, "We are working to ensure that A*STAR spinoffs get the most traction in the market. To do this, we must collaborate with the best partners to help co-create and grow our startups. A*ccelerate will focus on incubating technologies and developing products and services. Trendlines' ability to effectively incubate medical technology companies, will compliment this nicely."

Trendlines Medical Singapore CEO Eric Loh added, "This collaboration will leverage on A*ccelerate's productization capabilities and Trendlines' experience and proven track record in identifying, incubating, and developing medical technology companies. The initial intellectual property assets that we have identified can serve to address significant clinical needs with substantial market potential. We are excited to work closely with A*ccelerate to further develop these assets, commercialise products and solutions and benefit both patients and investors."
