### **Signing of a Non-Binding Letter of Intent by a Portfolio Company of The Trendlines Group Ltd. For the Sale of All of the Shares of Such Portfolio Company**

The board of directors (the “**Board**”) of The Trendlines Group Ltd. (the “**Company**” or “**The Trendlines Group**” and, together with its subsidiaries and associated companies, the “**Group**”) wishes to announce that a portfolio company of the Company is in negotiations with a public corporation (“**the PC**”) toward a definitive agreement for the sale of all of the shares of such portfolio company (“**Transaction**”) following the signing of a Non-Binding Letter of Intent (“**LOI**”) with the PC by the portfolio company.

**Shareholders and potential investors should note that there is no assurance that a definitive agreement will be entered into following the signing of the LOI or that the sale of the Company’s holdings in the portfolio company will be completed even after a definitive agreement has been entered into.**

In the event that the definitive agreement is signed and the sale of the portfolio company’s shares is completed, the Transaction is expected to have a material positive impact on the net tangible assets per share and earnings per share of the Group for the financial years ended/ending December 31<sup>st</sup>, 2019 and/or December 31<sup>st</sup> 2020.

The PC has demanded confidentiality with respect to the negotiations until the signing of a definitive agreement and therefore, in order not to prejudice the ability of the portfolio company to finalize such a definitive agreement, the Company will announce further information regarding the aforesaid Transaction only upon the signing of the definitive agreement. The Company will also make further announcement(s) in the event that a definitive agreement is not entered into by the expiry date of the LOI or if the LOI is terminated.

#### **Interest of Directors and Substantial Shareholders**

The Company’s non-executive Director, Zeev Bronfeld, is a minority shareholder of the portfolio company. Save for the above, none of the Company’s Directors, substantial shareholders and/or any of their respective associates has any interest, direct or indirect (other than through their shareholdings in the Company), in the above Transaction.
